

Samuel Franklin, 22, Bob Gray Road Knovillle, was charged with DUI, and Reckless Endangerment.

Officer Ketner LCPD, was dispatched to a accident at Zaxbys on Highway 321. Officer arrived on scene and noticed that a vehicle had hit the building, causing significant damage to the outside as well as the inside. The tables against the wall had also been pushed away from the wall due to the impact. Witnesses on scene identified the driver as Samuel Franklin and the passenger. Officer made contact with Franklin and he had a strong odor of alcohol coming from his breath, blood shots eyes, slurred speech and was unsteady on his feet at times. Passenger stated that they were in argument and Fraklin got upset, sped the vehicle

up and crashed into Zaxbys restaurant. Fraklin recklessly engaged in a conduct that placed the passenger and the people inside Zaxbys in imminent danger of death and/or serious bodily injury. Officer demonstrated SFST for Frankiln and he stated that he understood. During the Walk and Turn he stepped off the line, became unbalanced and could not follow the direction to count each step. During the One leg Stand he could not keep his balance and placed his foot down several times. When asked to say the alphabet from E-Q he became confused and was mixing up the letters. Franklin stated that he had smoked marijuana and consumed alcohol the night before. Franklin agreed to the implied consent and blew .124 on the Intoximeter.





The evidence further showed that officers and detectives with the Sevier County Sheriff's Office responded to the overdose death of a Kodak, Tennessee resident on Thanksgiving morning, November 22, 2018. Through the overdose investigation, it was determined that Williams distributed the drugs that resulted in that death. Finally, the prosecution also presented evidence that on March 27, 2019, agents seized quantities of heroin, fentanyl, and acetyl fentanyl, a firearm and ammunition, and over \$10,000 in cash from Wil-

Acting United States Attorney Francis M. Hamilton III and Homeland Security Investigations ("HSI") Special Agent in Charge Jerry C. Templet Jr. made the announcement.

This case was prosecuted as part of Operation Synthetic Opioid Surge (SOS), a Department of Justice program that seeks to reduce the supply of deadly synthetic opioids in high impact areas and to identify wholesale distribution networks and international and domestic suppliers.

Law enforcement agencies participating in the joint investigation which led to the indictment and subsequent conviction of Williams include the Sevier County Sheriff's Office ("SCSO") and HSI with the participation and assistance of the Sevier County Street Crimes Unit, the Tennessee Bureau of Investigation, and the U.S. Marshal's Service.

Assistant United States Attorneys Brent N. Jones and Anne-Marie Svolto represented the United States at trial.

Maryville Man Sentenced To 45 Years In Federal Prison For

Child Exploitation Crimes
The Honorable Thomas A.
Varlan, United States District
Judge for the Eastern District

of Tennessee, sentenced Tywan Montrease Sykes, 46, of Louisville, Tennessee, a previously registered sex offender, to serve 45 years in federal prison on child exploitation charges. A federal jury convicted Sykes's in March 2021 of charges of production of child pornography, enticement of a minor for illegal sex, committing those offenses while being required to register as a sex offender, and possession of child pornography. Sykes had been previously convicted of statutory rape in 1998 and aggravated statutory rape in 2012.

Following his release from prison, the United States Probation Office will supervise the defendant for 30 years and he will be required to register as a sex offender in any state in which he resides, works, or attends school.

"This case demonstrates our commitment to protecting our children through the prosecution of recidivist child predators to the fullest extent of the law," said Acting United States Attorney Francis M. Hamilton, III.



"The lengthy sentence in this case shows the significant punishment child predators face for their incomprehensible ac-

tions," said Homeland Security Investigations (HSI) Nashville Special Agent in Charge Jerry C. Templet, Jr. "HSI will continue to work with our law enforcement partners to remove these offenders from our communities and protect their vulnerable young victims."

According to the evidence presented at trial, the investigation began after Facebook notified the National Center for Missing and Exploited Chil-dren (NCMEC) that Sykes was soliciting a 15-year-old girl for sex and child pornography with messages he sent to the girl through Facebook. NCMEC notified the Knoxville Police Department's Internet Crimes Against Children unit (KPDwhich immediately ICAC), contacted the local Department of Children's Services office to help identify the girl and ensure her safety. KPD-ICAC arrested the defendant within 48 hours after the minor was interviewed. Federal search warrants were used to obtain the defendant's and the victim's Facebook communications and to search the defendant's phone. which revealed substantial evidence that was used at trial to convict Sykes.

Bradley Williams, 29, Oakland Road Sweetwater, was charged with Simple Possession x3.

Deputy Harrison LCSO, observed a black Chevy Silverado traveling on Highway 321 without a visible registration plate. Deputy conducted a traffic stop on the vehicle on Highway 321 at Highway 11. Upon making contact with the driver, Bradley Williams, Deputy asked him for the registration to the vehicle and while he was retrieving it from the glove box Deputy observed a "loaded" syringe in plain view inside the glove box. Williams stated it was not his at which point Deputy had him exit the vehicle. Deputy asked Wil-

Based on the above facts, Deputy placed Williams in custody for simple possession casual/casual exchange x3 and the active warrant out of Roane County. Monev Makers arrived and towed the vehicle. This did occur in Loudon County, Tennessee.
