PAROLE – DENIED! Attempted Murderer and Child Molester denied parole thanks to Johnson’s efforts

Thousands Stolen From Victim; One Charged with Theft

Back in June, District Attorney, General Russell Johnson opposed parole of two high profile Loudon County defendants - Kimberly Hopkins and Courtney Bingham.

Hopkins was convicted by Johnson of attempting to murder her adoptive mother, who still lives in Tellico Village. Hopkins tried to suffocate her mother in the back bedroom of the residence hall, tying her mothers hands to a chair and putting a bag over her head, trying to suffocate her. This was a convoluted scheme where she

Assistant District Attorney General James ‘Jimmy Pope’ Pope III died Monday from complications of a stroke that he originally suffered on Wednesday. He lived in Pikeville, which is an hour-plus drive each day from the 9th DAG Office in Kingston, I drive he had been making almost every day since September 1 when he joined Russell Johnson’s District Attor-

ney journal office. Jimmy Pope also just turned 59 years old on June 30th.

Johnson explained that Pope came to work with him September 1 of last year with 29 years of experience working as an assistant DA in the 12th district, which is a neighboring district of five counties to the south and west of the 9th district. Over in the 12th District he had handled cases

Dermatologist Agrees To Pay \$6.6 Million To Settle Allegations Of Fraudulent Billing Practices

Dermatologist, John Y. Chung, M.D., and his practice Skin Cancer & Cosmetic Dermatology Center, P.C. (“SC-CDC”), which operates 13 dermatology clinics in southeast Tennessee and north Georgia, have agreed to pay \$6.6 million to resolve allegations that they violated the False Claims Act by knowingly submitting false claims to federal healthcare programs for Mohs Micrographic Surgeries and other der-

matological procedures.

This settlement resolves allegations that Dr. Chung and SCCDC knowingly submitted false claims for payment to Medicare, Medicaid, and other government payors for Mohs procedures that were billed as if both the surgery and pathology portions of the procedures were performed by Dr. Chung, when in fact at least one portion was often performed by other individuals. The settlement

further resolves allegations that SCCDC regularly billed Medicare for multiple procedures, performed on the same patient on the same day, in a manner that improperly circumvented Medicare’s “multiple procedure reduction rule.” The alleged misconduct occurred from 2010 through 2020.

“Government health-care programs establish

convinced her mother she was going to give her a man-icure. Hopkins had traveled all the way from Oregon to surprise her parents for Father's Day, even though she had not seen her parents in years. The obvious motive was to obtain her inheritance upon their death.

Her elderly father was in a front room and heard his wife call out and was able to foil Hopkins's attempt to run out of the house and was later arrested.

Since her conviction, Hopkins is father has died leaving her mother to have to live by herself. Johnson acknowledged that the mother is supportive of her daughter's release, but Johnson emphasized that this situation would leave the mother vulnerable to further attempts

by her daughter to end her life. Johnson also appeared and opposed parole for Hopkins two years ago when she first came up for parole.

Bingham, on the other hand, was convicted of having sex with an underage, minor in her own home with her husband and children sleeping in other rooms. This child was a member of Bingham's church. We're being them had taken youths on church outings. This is Bingham's first opportunity for parole.

The parole board decision came down, denying parole for both defendants who are now in Inmate and TDOC's custody. Both parole decisions are final for Kimberly Hopkins and Courtney Bingham.

Hopkins will be back up again in June 2025, Bingham will not be back up again un-

til June 2028.

Hopkins did not have anyone attend, though her mother (who was the victim in the attempted murder charge) wrote a letter requesting that she receive parole.

Bingham had a couple women testify that have been giving her counseling services during her time in prison, and we believe her mother was there.

These are now all video hearings that we attend at the TDOC satellite office on Elm Street in Knoxville. The hearings no longer take place at the actual prison since Covid.

Johnson explained that the video wasn't working for the Bingham hearing and so you

couldn't see anyone on that side of the hearing.

Johnson's office attends only selected parole hearings.

"We only weigh in on those that we feel are most deserving and where our input provides something about the facts of the case that may not be apparent to the Parole Board from reading the record. We do not want to wear out our welcome and 'water down' our voice by always showing up. Besides, at the rate, TDOC is pushing people up for parole these days, especially females under a safety valve argument, there is no way we could possibly do everything else we have to do."

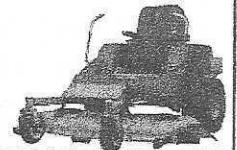
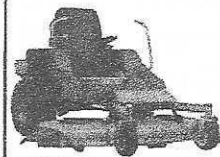

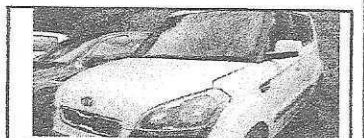

billing rules and guidelines to safeguard tax-payer funds. Billions of dollars intended to cover the costs of healthcare services are lost every year to fraud, waste, and abuse, and when providers disregard billing requirements, the financial viability of public programs and the healthcare they provide are put at risk. The U.S. Attorney's Office will aggressively root out providers whose billing practices take advantage of public programs for their own private gain," said U.S. Attorney Francis M. Hamilton III.

"When health care providers submit improper claims to federal health care programs, they waste valuable taxpayer dollars," said Special Agent in Charge Tamala E. Miles of the Department of Health and Human Services Office of Inspector General (HHS-OIG). "Working with our law enforcement partners, our agency will continue to protect federal health care programs from fraud, waste, and abuse to ensure they can be used for their intended purposes."

"Health care fraud, a severe problem that impacts every American, costs our country billions each year, takes critical resources out of our health care system, and contributes to the rising cost of health care for everyone. The FBI, along with our federal, state, and local partners, will continue to provide resources to investigate

allegations of fraud in public programs and hold violators to account," said FBI Special Agent in Charge Joseph E. Carrioco, Knoxville Field Office.

"The VA OIG is dedicated to ensuring veterans receive the quality health care they deserve, and we will continue to work to make certain that VA healthcare programs are not compromised by fraudulent billing practices," said Special Agent in Charge Kim R. Lampkins with the Department of Veterans Affairs Office of Inspector General's Mid-Atlantic Field Office. "The VA OIG thanks the US Attorney's Office, and our law enforcement partners for their efforts in this investigation."

"To protect the integrity of federal health care programs and the patients they serve, it is important that providers are compliant with billing rules and procedures," said TVA OIG Inspector General Ben Wagner. "The TVA OIG is committed to identifying and investigating healthcare false claims that negatively impact the people of the Tennessee Valley. The TVA-OIG will continue to work tirelessly alongside our law enforcement partners to protect the reliability of federal healthcare programs, and prevent fraud, waste, and abuse. The TVA OIG would like to thank the United States Attorney's Office Eastern District of Tennessee for diligently pursuing resolution of this case and ensuring funds were properly

returned to TVA."

"Health care providers that serve our nation's military service members, retirees and their families are expected to meet the highest standards of ethical and professional behavior," stated Special Agent in Charge Darrin K. Jones, DoD Office of Inspector General, Defense Criminal Investigative Service (DCIS), Southeast Field Office. "This settlement sends a clear signal to those who take advantage of TRICARE for personal enrichment."

"Our Medicaid Fraud Division works each day to uphold the integrity of Georgia's Medicaid program," said Georgia Attorney General Chris Carr. "This includes putting a stop to providers who submit false claims and take advantage of our publicly funded healthcare system. This type of fraud and abuse will not be tolerated as we continue our efforts to protect taxpayer dollars no matter the amount."

As part of the settlement, Chung and SCCDC entered an Integrity Agreement (IA) with the U.S. Department of Health and Human Services – Office of Inspector General (HHS-OIG), which promotes its future compliance with the statutes, regulations, program requirements, and written directives of Medicare and all other federal health care programs. The IA focuses on the practice's continuing obligation to accurately bill and properly submit reimbursement claims

to government payors.

This investigation resulted from a coordinated effort between HHS-OIG (Nashville Field Office), the Federal Bureau of Investigation (Knoxville), Tennessee Bureau of Investigation, Defense Criminal Investigative Service, Tennessee Valley Authority – OIG, U.S. Department of Veterans Affairs – OIG, the U.S. Attorney's Office for the Eastern District of Tennessee, the Tennessee Attorney General's Office, and the Georgia Attorney General's Office. The investigation was prompted by a lawsuit filed under the qui tam, or whistleblower, provisions of the False Claims Act, which permits private parties to sue on behalf of the government for false claims, and to receive a share of any recovery. The qui tam case is captioned United States, State of Tennessee and State of Georgia ex rel. Chambers v. Skin Cancer and Cosmetic Dermatology Ctr. and Chung, No. 1:20-CV-177 (E.D. Tenn.). The relator's share of the recovery will be \$1.32 million.

Assistant U.S. Attorneys Jeremy Dykes and Alexa Ortiz Hadley represented the United States. Senior Assistant Attorney General Tony Hullender represented the State of Tennessee, and Assistant Attorney General Sara Vann represented the State of Georgia.

The claims settled by this agreement are allegations only, and there has been no determination of liability.

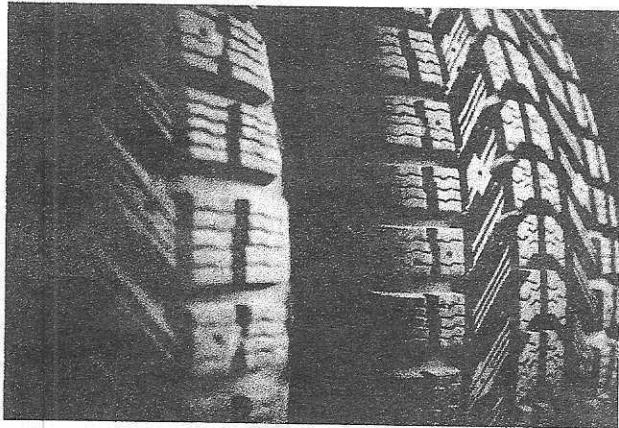
